The US Department of Veterans Affairs (VA) is preparing environmental documentation to assist in the Federal decision-making process concerning the acquisition of an at least 200acre site for the development and operation of a new National Cemetery near Albuquerque, New Mexico (Proposed Action). The proposed National Cemetery would be located on one of the following two potential sites:

- <u>Sandoval County Site:</u> Approximately 225 acres of land located at the northwest corner of Northwest Loop Road and US Route 550 in the City of Rio Rancho, Sandoval County, New Mexico. This site is undeveloped, generally level, mostly grassy land that has been platted and divided for mixed-use development. The location of the Sandoval County Site is shown in <u>Attachments 1a 1c.</u>
- <u>Bernalillo County Site:</u> Approximately 230 acres of land located at the southwest corner of Shooting Range Road and Altrisco Vista Boulevard, Bernalillo County, New Mexico. This site consists of undeveloped, generally level, pasture land. The location of the Bernalillo County Site is shown in <u>Attachments 1a, 1d, and 1e.</u>

Construction details for the proposed National Cemetery development are unknown at this time. However, the proposed National Cemetery would include the development of the necessary infrastructure associated with a cemetery (e.g., roads, water supply, grave sites, committal structure, support structures, and fencing). Through the VA's site screening and selection process, the proposed sites have been identified as being physically and operationally best suited to meet the purpose of and need for the proposed National Cemetery for a variety of reasons.




### Location Map Proposed Albuquerque National Cemetery Bernalillo and Sandoval Counties, New Mexico


Aerial Location Map Proposed Albuquerque National Cemetery Sandoval County Site Rio Rancho, Sandoval County, New Mexico


Topographic Location Map Proposed Albuquerque National Cemetery Bernalillo County Site Bernalillo County, New Mexico

This letter is in response to your letter dated August 25, 2017, requesting the U.S. Army Corps of Engineers' (Corps) provide information regarding environmental issues in the vicinity of the proposed action pursuant to the National Environmental Policy Act (NEPA) of 1969.

In response to your request, the Corps has reviewed the proposed locations for environmental issues, focusing on those topics where the Corps would have specialized knowledge of issues above that of the other agencies you have contacted through scoping.

Corps personnel from the Environmental and SRM Section reviewed the proposal and found that there are several Munition Response Sites (MRS) in the near vicinity of the property located adjacent to the Double Eagle airport (see attached map). These locations lie within a Formerly Used Defense Site (FUDS) that consist of World War II era precision bombing targets where live 100-lb general purpose bombs and practice bombs have subsequently been found and blown in place. Since these bombing targets were used by trainees, accuracy varied, and inert or live ordnance could have ended up on the property in question. The proposed site for the National Cemetery lies within the FUDS boundary and is adjacent to the former Volcano Target (see attached map). The Corps recommends that third party Unexploded Ordnance (UXO) support be included as part of any future construction activities that involve ground intrusion in this particular area.

Finally, the Environmental Resources staff reviewed the proposed locations and found that both the areas have had some previous archaeological inventory. The northern parcel was inventoried in 1998 and identified three known prehistoric archaeological sites. The parcel by the Double Eagle airport was inventoried in 1976 and no archaeological sites were identified. However, adequacy of cultural inventory and eligibility of sites are the responsibility of the lead federal agency in consultation with the State Historic Preservation Office. With regard to wildlife issues, we are unaware of any significant issues. However, the lead federal agency should perform surveys for Migratory Bird Treaty Act species with emphasis on grassland birds, and consult with USFWS on these issues as needed.



Thank you for providing the Natural Resources Conservation Service (NRCS) the opportunity to review the proposed Albuquerque National Cemetary Project, Sandoval and Bernalillo Counties, New Mexico.

The Farmland Protection Policy Act (FPPA) authorizes the NRCS to provide review of proposed projects that have the potential to irreversibly convert farmlands to non-farmland or irreversibly converting hydric areas to non-hydric uses as the result of programs funded by the federal government. In review of the information provided on the project, it is determined that the entire project is located in an urban or development area in an existing easement, or is in an area not designated as Prime or Important Farmland. The FPPA rules define farmland conversion to be "to the extent that it irreversibly converts farmland to other purposes", this project is not expected to have that effect. With this acknowledged, the proposed project will not cause Prime or Unique Farmlands or hydric soils to be converted to non-agricultural or non-hydric uses, and is not subject to the Act.

The New Mexico Department of Game and Fish (Department) has reviewed your 25 August 2017 letter regarding the above-referenced project. The sites proposed for potential development include undeveloped grassland or rangeland. These habitats are known to support burrowing owls (*Athene cunicularia*) within Bernalillo and Sandoval counties, and owls could occur within the project proposed project sites Burrowing owls are protected from take by the Migratory Bird Treaty Act and by New Mexico state statutes. Construction activities near nesting burrowing owls can lead to abandonment of eggs or nestlings and result in take. Therefore the Department requests that before construction begins, a qualified surveyor search the project area for burrowing owls during their breeding season (April 1 through July 31). Diurnal surveys should not be conducted if temperatures exceed 86 degrees Fahrenheit or winds exceed 12 miles per hour. The Department's recommended survey protocol can be found at

wildlife.state.nm.us/conservation/habitat handbook/index.htm. Should burrowing owls be found occupying the site, the Department recommends implementing construction activities outside of periods when owls would be present on their breeding areas, which could extended as late as October.

If no burrowing owls are found occupying the selected site, the Department does not anticipate significant effects to wildlife or important habitats from implementation of this project.

I am in receipt of a request for information from TTL Associates Dated August 25, 2017 regarding the NEPA research for a new national cemetery in Bernalillo County. I have received the requests for both the Natural Resource Services Section and also the Infrastructure Planning and GeoResources departments within the County.

Please add to your distribution list the Mid-Region Council of Governments <u>Home - www.mrcog-nm.gov</u>. That agency deals with many of the transportation related studies that have been conducted for ATRISCO VISTA Boulevard (your spelling in the letter is incorrect) including recent preliminary engineering studies for widening of Atrisco Vista which is of interest to one of our County Commissioners. MRCOG has ready access to those reports and findings, as well as to related studies for creation of a major linkage north of I-40 to Rio Ranch through a proposed construction/extension of Paseo Del Volcan into Rio Rancho. They would also be the coordinating agency for traffic for the Sandoval County site. The future development plans and long range transportation plans and traffic studies that MRCOG could provide for both sites would fall into the realm of ""Traffic Concerns" and "Socioeconomic concerns" as Atrisco Vista is slated for industrial/commercial development, particularly south of the airport due to its ready proximity to I-40.

You will also need to contact the City of Albuquerque Aviation Department regarding the Double Eagle Airport operations located immediately north of the proposed site. That airport is a general aviation airport, but also is utilized by Kirtland AFB as a short hop training air corridor for helicopter operations (contact Kirtland AFB, 377<sup>th</sup> Air Base Wing 200 Wyoming Blvd. NM 87117 – Col. Richard W. Gibbs)

Regarding soils on the site – that information is available through the NRSS website soil surveys. That location is I believe aeolian sand dune deposits which are susceptible to wind erosion if disturbed, so a low impact approach to development will likely be needed. This has been of much concern recently in a large scale master plan development case that has been handled by the County. (Soils, potential air quality concern),

Regarding parks etc. Please note that there is an active shooting range and training facility (City of Albuquerque) located a few miles to the northwest. It is the primary gun range for both the City of Albuquerque Police Department and for Bernalillo County Sheriffs Department (which also stage air support units out of Double Eagle Airport). This may be of some noise concern for the use of the cemetery. The Petroglyphs National Monument also has access of Atrisco Vista and is located to the north east of the proposed site. You would likely need to contact the National Park Service as part of the NEPA study to address their concerns directly.

Depth to groundwater in the area is on the order of several hundred feet. Please contact the Albuquerque Bernalillo County Water Utility Authority (ABCWUA) - Katherine Yuhas <u>Welcome to the Albuquerque Water Utility Authority</u>, as there is an active production well located a few miles south of the proposed site. That would likely be the most current water level data. There is also one USGS monitoring well located on the northeast corner of the ABCWUA land application facility and northeast of Double Eagle Airport – depth to water in that well is routinely on the order of 900 feet, but that is a few miles away to the northwest of the site. The road located immediately north of the site is also the access way for ABCWUA sludge haul trucks taking loads to the land treatment facility. I am unaware of any wells being located on the subject property, but you would need to confirm that with the New Mexico Office of the State Engineer. Water for irrigation might be available via the ABCWUA, but if well irrigation is intended that would require a water rights acquisition which would need to be worked through the NMOSE District 1 Office (<u>New Mexico Office of the</u> <u>State Engineer/Interstate Stream Commission</u>)

Please contact Bernalillo County Planning and Development Services with regard to permitting requirements for a cemetery. I don't believe that the property is currently zoned to allow that use, so some zoning/special use coordination would be needed. That contact would be Mr. Enrico Gradi, but I believe that he is already on your distribution list.




Figure 2: Topographic Site Location Map

The U.S. Department of Veterans Affairs (VA) is preparing a Draft Environmental Assessment (EA) to analyze the potential environmental impacts associated with the Proposed Action to acquire, construct, and operate a new National Cemetery on approximately 230 acres of land located at the southwest corner of Atrisco Vista Boulevard and Shooting Range Access Road in Bernalillo County, New Mexico (Site). The Site is currently unimproved and mostly grassy pastureland. The location of the Site is shown on Figures 1 and 2. The Site features are depicted on Figure 3.

The cemetery would include a gated entrance and perimeter fencing, an administration building and public information building, an assembly area, a memorial wall, committal shelters, a loop road through the cemetery, casket gravesites, columbarium niches, and a maintenance facility. The cemetery would be developed in phases, with the first phase (approximately 40 to 60 acres) including the buildings and infrastructure needed to support the first 15-years of burial capacity. The first phase of cemetery development would begin following site acquisition.

The **purpose** of the Proposed Action is to establish a new National Cemetery of sufficient size and capacity to serve the projected burial needs of Veterans in central New Mexico. The Proposed Action is **needed** to address the depletion of National Cemetery burial space in central New Mexico.

This scoping notice will also be published in the Albuquerque Journal to inform and solicit input from the public. The notice is also available on the VA website at <a href="https://www.cfm.va.gov/environmental">https://www.cfm.va.gov/environmental</a>.

VA will prepare the Draft EA according to the National Environmental Policy Act (NEPA) of 1969 (42 U.S. Code 4321-4370h), the Council on Environmental Quality Regulations Implementing the Procedural Provisions of NEPA (40 Code of Federal Regulations [CFR] 1500-1508), and VA Implementing Regulations (38 CFR Part 26).

VA recognizes that you as an identified Stakeholder and/or your organization may have comments on the scope of issues for analysis or information relevant to the Proposed Action for consideration in the Draft EA. 

## Figure 1: Site Location Map

## Introduction

The United States Department of Veteran's Affairs (VA) has requested review and comment on the Albuquerque National Cemetery Environmental Assessment (EA) Scoping.

## Comments

## Drinking Water

There are no regulated public groundwater system wells within 10 miles of the proposed site, nor any regulated public surface water system intakes within 10 miles downgradient. Therefore, this project is unlikely to have a significant impact on any regulated public water system.

If the proposed project includes public drinking water infrastructure to accommodate the new facilities, it may require either approval from or written notice to the New Mexico Environment Department Drinking Water Bureau (DWB). Please review 20.7.10.200 NMAC or contact the DWB to determine which option is appropriate. In either case, the water system should submit an Application for Construction or Modification of Public Water Supply System if it has not already done so. Please review the complete application requirements at: https://www.env.nm.gov/forms/.

## Groundwater

NMED staff reviewed the information submitted, focusing specifically on the potential effect to ground water resources in the area of the proposed project.

State of New Mexico Ground and Surface Water Protection regulations in 20.6.2.1201 New Mexico Administrative Code (NMAC) include requirements for when to file a Notice of Intent to Discharge for any person intending to make a new water contaminant discharge or to alter the character or location of an existing water contaminant discharge. The notice shall be filed with the NMED Ground Water Quality Bureau for discharges that may affect ground water, and/or the Surface Water Quality Bureau for discharges that may affect surface water.

Onsite wastewater systems with design flows of more than 5,000 gallons per day must be constructed and operated in accordance with Ground Water Discharge Waste permits approved by the NMED Ground Water Quality Bureau. If domestic wastewater is to be delivered offsite to an existing municipal or regional wastewater treatment system, an additional permit will not be required by NMED.

## Petroleum Storage Tank

The proposal contains no actions that will impact known petroleum storage tank systems currently regulated under 20.5 NMAC within 1-mile of the project area and does not appear to propose the installation of new petroleum storage tank systems. There are no registered active petroleum storage tank facilities and no confirmed petroleum storage tank releases (leaks or spills) within ½ mile of the project area. If an abandoned storage tank system or petroleum impacted soil or water is discovered during construction, the Petroleum Storage Tank Bureau must be notified (20.5.118 NMAC, etc.). Contact

the Leak of the Week here during business hours: https://www.env.nm.gov/petroleum\_storage\_tank/ (see box to the right, Report a Leak or Spill) or call 505-476-4397. During non-business hours, call 505-827-9329. Owners, operators, and others dealing with petroleum storage tank systems must comply with all regulations in 20.5 NMAC, New Mexico's Petroleum Storage Tank regulations.

Facilities where NMED's petroleum storage tank database shows all petroleum storage tanks have been removed or closed and does not show a release and facilities and releases unknown to the Petroleum Storage Tank Bureau are not included in this comment.

## Surface Water Quality

NMED has reviewed the US Department for Veteran Affairs (VA) scoping notice for the proposed Albuquerque National Cemetery, focusing on the potential effects to surface waters in the area of the proposed project.

Specific to the project, the VA should manage the projects to manage stormwater during construction with appropriate best management practices and ensure that that stormwater drainage is appropriately planned/managed. NMED encourages the use of green infrastructure and low impact designs.

## Clean Water Act, Section 402 NPDES Industrial Storm Water Construction General Permit (CGP)

The USEPA may require National Pollutant Discharge Elimination System (NPDES) Construction General Permit (CGP) coverage for storm water discharges from construction activities (such as clearing, grading, excavating, and stockpiling) that disturb (or re-disturb) one or more acres, including expansions, of total land area. Prior to discharging storm water, construction operators may need to obtain coverage under an NPDES permit.

A Construction General Permit (CGP) is not required if the disturbing activities are part of the normal dayto-day operation of a completed facility (e.g., daily cover for landfills, maintenance of gravel roads or parking areas, landscape maintenance. If work performed is routine maintenance that is performed to maintain the original line and grade, hydraulic capacity, or original purpose of the facility.

Among other things, the CGP requires that a Stormwater Pollution Prevention Plan (SWPPP) be prepared for the project, including support and staging areas, and that appropriate best management practices (BMPs) be installed and maintained both during and after construction to prevent, to the extent practicable, pollutants (primarily sediment, oil and grease, and construction materials from construction sites) in storm water runoff from entering waters of the United States (WOTUS) like the Rio Grande. This permit also requires that permanent stabilization measures (re-vegetation, paving, etc.), and permanent storm water management measures (storm water detention/retention structures, velocity dissipation devices, etc.) be implemented post construction to minimize, in the long term, pollutants in storm water runoff from entering the Rio Grande or other Waters of the US.

Part 9 of the 2022 CGP includes permit conditions applicable to specific states, Indian country lands, or territories. In the State of New Mexico, except on tribal land, permittees must ensure that there is no increase in sediment yield and flow velocity from the construction site (both during and after construction) compared to pre-construction, undisturbed conditions (see Subpart 9.6.2 of the 2022 CGP.

The US EPA Requires that all "operators" obtain NPDES permit coverage for construction projects. Generally, this means at least two parties will require permit coverage. The owner/developer of this construction project who has operational control over project specifications; the general contractor who has day-to-day operational control of those activities at the site, which are necessary to ensure compliance with the SWPPP and other permit conditions; and possibly other "operators" will require appropriate NPDES permit coverage for this project.

## NPDES Municipal Storm Sewer Systems Permit

Polluted stormwater runoff is commonly transported through municipal separate storm sewer systems (MS4s), and then often discharged, untreated, into local water bodies. EPA requires certain operators to obtain NPDES permits and develop stormwater management programs (SWMPs) to prevent pollutants from entering MS4s. The SWMP describes the stormwater control practices that will be implemented consistent with permit requirements to minimize the discharge of pollutants from the sewer system.

The proposed Albuquerque National Cemetery is within the boundaries of Census-designated Middle Rio Grande Watershed (MS4 permit number NMR04A00). The project will be required to comply with MS4 permit requirements and stormwater management practices of MS4 permit number NMR04A00 permitted entities, including the City of Albuquerque (NMR04A014), Bernalillo County Stormwater Program (NMR04A008), and Albuquerque Metropolitan Arroyo Flood Control Authority (NMR04A016).

## USACE Section 404 Dredge and Fill Permits and NMED 401 Certifications

If construction activities or disturbances were to take place requiring discharge of dredge/fill material or activities were to take place in the riverbanks and wetlands, a 404 dredge and fill permit is required by the US Army Corps of Engineers.

The U.S. Army Corps of Engineers (USACE) regulates the discharge of dredged or fill material into waters of the United States, including wetlands, under Section 404 of the Federal Clean Water Act (CWA). The USACE issues or authorizes Standard Individual Permits (IPs), Nationwide Permits (NWPs), and the Emergency Regional General Permit (RGP) for activities such as earth-moving work within wetlands, lakes, and streams (including ephemeral streams or arroyos) that are waters of the United States. If you have questions about activities within watercourses or wetlands that may require coverage under a CWA Section 404 permit, then more information is available on-line from the USACE, Albuquerque District, Regulatory Division at <a href="http://www.spa.usace.army.mil/Missions/Regulatory-Program-and-Permits/">http://www.spa.usace.army.mil/Missions/Regulatory-Program-and-Permits/</a>.

A water quality certification is required under Section 401 of the Federal CWA for activities regulated under Section 404. The mission of the U.S. Department of Veterans Affairs (VA) National Cemetery Administration (NCA) is to honor Veterans and their families with final resting places in national shrines and with lasting tributes that commemorate their service and sacrifice to our Nation. In order to fulfill this mission, VA proposes to acquire an at least 200-acre site for the development and operation of a new National Cemetery near Albuquerque, New Mexico (Undertaking). The proposed National Cemetery would be located on one of the following two potential sites:

- <u>Sandoval County Site:</u> Approximately 246 acres of land located at the northwest corner of Northwest Loop Road and US Route 550 in the City of Rio Rancho, Sandoval County, New Mexico. This site is undeveloped, generally level, mostly grassy land that has been platted and divided for mixed-use development. The location of the Sandoval County Site is shown in <u>Attachments 1a – 1c.</u>
- <u>Bernalillo County Site:</u> Approximately 230 acres of land located at the southwest corner of Shooting Range Road and Atrisco Vista Boulevard, Bernalillo County, New Mexico. This site consists of undeveloped, generally level, pasture land. The Bernalillo County Site has been unimproved land since at least 1888. The location of the Bernalillo County Site is shown in <u>Attachments 1a, 1d, and 1e</u>.

Construction details for the proposed National Cemetery development are unknown at this time. However, the proposed National Cemetery would include the development of the necessary infrastructure associated with a cemetery (e.g., roads, water supply, grave sites, committal structure, support structures, and fencing). An APE of the boundaries of the selected site would be suitable for direct effects. A radius of 0.25-mile around the selected site will address potential indirect effects to historic properties in the area.

## **Identification of Historic Properties**

Identification efforts included limited walking surveys of the sites by an architectural historian who exceeds the Professional Qualification Standards established by the Secretary of the Interior, and a records and literature search of New Mexico Historic Preservation Division (NM SHPO) files via the New Mexico Cultural Resources Information System. The surveys also included limited pedestrian and windshield surveys of adjacent areas within one mile of the sites. The windshield surveys were limited to the right-of-way for the surrounding areas.

## **Built Resources**













I am writing in response to your letter, received at the New Mexico State Historic Preservation Office (SHPO) on October 30, 2017, concerning the above referenced project. We look forward to continuing Section 106 consultation on the project, although it may not be necessary for us to attend a consulting party meeting. I offer some comments on the proposed project areas below, for your consideration as the consultation process moves forward.

**Sandoval County Site.** Your letter references a final report completed in 2006 for the Hawk project. Our records show the submittal of a survey report and a copy of an archaeological testing report for this area. We do not have evidence of being provided a copy of the final report. If this location is selected for the new cemetery, we will need a copy of the final report in order to continue consultation.

**Bernalillo County Site.** Your letter indicates that we do not have record of previous archaeological investigations on the Bernalillo County site. In fact, there has been some archaeological survey; but this survey is more than 20 years old and did not cover the entire project area. Therefore, we recommend that if this site is selected, a professional archaeologist conduct an intensive pedestrian survey of the area to document any archaeological sites or other historic properties that might be present.

Lastly, your letter indicates that there are no TCPs within either project area, but your letter does not say if Veterans Affairs has conducted consultation with Native American Tribes. A list of tribes who wish to be contacted for projects occurring in Sandoval and Bernalillo Counties can

To fulfill this mission, VA proposes to acquire an approximately 230-acre parcel for the development and operation of a new National Cemetery near Albuquerque, New Mexico (Undertaking). This Undertaking was previously presented to your office as one of two parcels under consideration in a letter dated October 18, 2017 (see Attachment D).

The proposed cemetery parcel consists of approximately 230 acres of land located at the southwest corner of Shooting Range Road and Atrisco Vista Boulevard, Bernalillo County, New Mexico. This parcel consists of undeveloped, generally level, pastureland. This parcel has been unimproved land since at least 1888. The location of the Bernalillo County parcel is shown in Attachment A.

## Undertaking

As noted above, the Undertaking is the acquisition, construction, and operation of an approximately 230acre parcel for a new National Cemetery near Albuquerque, New Mexico. Construction details for the proposed National Cemetery development are unknown at this time. However, the proposed National Cemetery will include the development of the necessary infrastructure typical of other National Cemeteries, including site preparation for interment, in-ground burials with standard NCA markers, the construction and use of columbaria and other receptacles for cremated remains, and the construction and use of a chapel, and/or support buildings. Installation of roads, fences, entrance gates, a flagpole, and landscaping, and construction of support facilities and additional utilities are also anticipated. These assumptions include that any buildings added to the parcel will not exceed two stories in height. If construction plans deviate markedly from these assumptions, effects to historic properties may need to be reevaluated.

## **Area of Potential Effects**

The area of potential effects (APE) is the geographic area or areas within which an undertaking may directly or indirectly cause alterations in the character or use of historic properties. The boundary of the selected 230-acre parcel is recommended as suitable for assessing physical effects related to the acquisition, construction, and operation of the cemetery. An additional radius of 0.25 miles surrounding the parcel described above is recommended as appropriate for assessing potential visual/auditory effects to historic

properties in the area. Therefore, for this undertaking, an area encompassing the 230-acre parcel plus an additional 0.25-mile radius buffer is recommended for an APE.

## **Identification of Historic Properties**

Identification efforts included limited walking surveys of the parcel in 2017 and 2022 by an architectural historian who exceeds the Professional Qualification Standards established by the Secretary of the Interior, and a records and literature search of New Mexico Historic Preservation Division (NM SHPO) files via the New Mexico Cultural Resources Information System. The survey also included limited pedestrian and windshield survey of adjacent areas within one mile of the parcel. The windshield survey was limited to the right-of-way for the surrounding area.

## **Built Resources**

The parcel is undeveloped with no extant buildings or structures. No National Historic Landmark (NHL) or National Register of Historic Places (NRHP)-listed or eligible properties were identified on the Bernalillo County parcel. One significant historic property was identified in the vicinity of the parcel; the western boundary of Petroglyph National Monument is located approximately 0.43-mile east of the parcel. One of the principal cultural resources of Petroglyph National Monument, the Three Sisters or Albuquerque Volcanoes, a sacred landscape to many Native American groups, is located approximately 0.75-mile east of the parcel. ### Archaeological Resources

In 2018, Okun Consulting Solutions (OCS) conducted a 100-percent (Class III) pedestrian cultural resource survey of the parcel and a visual inspection of a 50-foot area surrounding the parcel. The purpose of this investigation was to identify and evaluate all cultural resources within the parcel, potentially including historic districts, archaeological sites, linear resources, isolated occurrences (IOs), and historic buildings and structures over 50 years in age. All discovered resources were evaluated for their eligibility to the NRHP, and the potential effects of the proposed undertaking on all historic properties was assessed.

One linear resource (post-contact) and 26 IOs (14 pre-contact and 12 post-contact) were documented during survey of the parcel. The linear resource (HCPI 44595) is an early to mid-twentieth century road alignment consisting of a linear swale and associated artifacts. While the road is clearly visible and remains in good condition, it was likely a minor transportation route, and no mention of its construction or use was found in local transportation records. As a minor road, there is no evidence that the alignment was associated with important events or persons or that any such association would be demonstrably significant; the road does not visually convey a strong sense of time and place and therefore does not qualify for listing on the NRHP under Criteria A or B. The alignment lacks distinctive design or engineering characteristics and does not qualify for listing under Criterion C. Further, as a minor road, it is not likely to provide significant information about past use of the West Mesa and does not qualify for listing on the NRHP. No further management considerations are warranted for this resource. The 26 IOs documented during this investigation lack additional data potential and are not likely to increase our understanding of the past. Thank you for consulting with the State Historic Preservation Office (SHPO) regarding the proposed development and operation of a new National Cemetery in Bernalillo County, New Mexico. I have reviewed the archaeological survey report (NMCRIS 140024) prepared by Okun Consulting Solutions and concur with the Veterans Administration (VA) that the historic road segment (HCPI 44595) and the isolated occurrences are not eligible for listing in the National Register of Historic Places.

The SHPO concurs with the VA that there are no historic properties within the APE for direct effects. However, since the cemetery is located less than ½ mile from the boundary of Petroglyph National Monument, the Monument is within the visual effects APE. In our view, the undertaking will have no adverse effect on historic properties because the proposed cemetery will be visible but will comprise a low-lying, landscaped area with few buildings.

Thank you for your November 21, 2022, letter inviting the National Park Service (NPS) to participate in Section 106 consultation regarding the proposed acquisition and development of a new National Cemetery west of Petroglyph National Monument. We appreciate you providing us with the opportunity to comment on the proposal and being a part of the Section 106 consultation process.

Petroglyph National Monument (Monument) was designated by Congress in 1990 as a unit of the National Park System (Public Law 101-313) to protect, preserve, and interpret the prehistoric and historic rock art of the Rio Grande Valley. The NPS stewards the Monument's cultural and natural resources, including the landscape that is of profound meaning and significance for traditional communities within the middle Rio Grande Valley and the 29 associated Pueblos and Tribes that consider the Monument sacred. Recognizing the significance of the resources to the nation, Congress directed the Secretary of the Interior to administer, manage, and protect the Monument in partnership with the City of Albuquerque pursuant to the NPS Organic Act of 1916 to protect and conserve its cultural and natural resources "unimpaired for the enjoyment of future generations" (39 Stat. 535; 54 U.S.C. §§ 100101 et seq.). NPS staff work closely with the City of Albuquerque's Open Space Division to co-manage the Monument.

Some of the most significant features of the Monument are the cultural landscapes, including the five volcanoes located on the western side of the Monument that are sacred to 29 associated Pueblos and Tribes. Our recommendation is that the cemetery be designed to reduce or eliminate visual impacts to nearby Petroglyph National Monument.

As you develop the site plan and design, we request to be involved to determine if there could be an adverse effect on Monument cultural resources based on the design of the cemetery and potential effects to the viewshed of the Monument, including views from the Volcanoes. We would like you to include Petroglyph National Monument in your Visual Area of Potential Effect (APE) and would therefore like you to consider expanding the APE beyond the 0.25 mile as currently proposed. We suggest there be a full range of alternatives for the design that include the visual impacts, and a "water-wise" design incorporating low water and native vegetation. We request visual simulations of views for each alternative from key locations within the Monument. The NPS would be happy to coordinate access into the Monument to accomplish this work.

We trust that, through the National Historic Preservation Act (NHPA) Section 106 process, you will consult with and share the alternative designs with the Monument's 29 associated Tribes and Pueblos to

get their input and recommendations. As consultation with area Pueblos and Tribes is conducted, we would like to review the information that was provided to them, and any responses received. We would like to know if the Pueblos and Tribes were invited to be consulting parties under NHPA and if any were interested. Also, as stated in the November 2022 letter, in 2018 a Class III pedestrian cultural resources survey of the area was completed. We would like to review this information as this area is close to the Monument and may have a direct connection to the cultural resources and landscapes of the Monument.

The November 2022 letter mentioned that the 2018 survey recorded one linear resource within the APE, and that it was identified as an early to mid-twentieth century road alignment consisting of a linear swale and associated artifacts. Interestingly, we have a draft Cultural Landscape Inventory for Historic Roads and Trails that we are hoping to finalize over the next year that identifies historical routes within the Monument and provides draft recommendations for eligibility to the National Register of Historic Places (NRHP). There are a few historic routes that crossed through and extended beyond the southern portion of the Monument that have been identified as to be potentially eligible for listing on the NRHP. These include a wagon route and other historic routes. We recommend additional investigation of the linear route and would be happy to collaborate and share information that we have available on historic routes in the area to see if there is a connection with the routes that have been identified within the Monument. Also, the location of the proposed National Cemetery likely falls within the historical boundary of the Atrisco Land Grant.

Thank you again for the opportunity to comment on this proposal. We respectfully request continued communication regarding this project so that we may collaborate to minimize activities from impacting NPS resources and look forward to learning more about the potential range of project alternatives including alternative designs of the cemetery.

The U.S. Department of Veterans Affairs (VA) National Cemetery Administration (NCA) appreciates your response and welcomes your comments on the above-noted Undertaking. On November 21, 2022, NCA submitted a letter to consulting parties, describing the Undertaking, the work completed to identify historic properties, and VA's finding of effect. On December 14, 2022, you responded, recommending that the Area of Potential Effects (APE) for visual effects be extended to include the Petroglyph National Monument. VA agrees to expand the visual APE to include the Petroglyph National Monument (Attachment A) and accordingly changes the finding of effect from "no historic properties affected" (36 CFR 800.4(d)(1)) to "no adverse effect" to historic properties (36 CFR 800.5(b)).

On December 6, 2022, VA received a response from the New Mexico (NM) State Historic Preservation Officer (SHPO) (Attachment B). The NM SHPO concurred on VA's determination that the linear resource/road identified in the 2018 Class III pedestrian cultural resources survey of the area is not eligible for listing on the National Register of Historic Places and concurred on a finding of no adverse effect to historic properties for the Undertaking. VA thanks the National Park Service (NPS) for the offer to share information on the historic routes in the area. While VA does not plan to conduct additional archaeological investigations, we welcome any additional information NPS would like to provide. For more information and as requested, please see "A Cultural Resource Survey for the Proposed Albuquerque National Cemetery, Albuquerque West Mesa, Bernalillo County, New Mexico" (Attachment C).

For the current Undertaking, VA invited 37 parties to consult, including 28 Indian tribes (see Table 1 below). The tribes invited included all the tribes originally invited in the 2017 consultation, as well as all the tribes listed on the NM SHPO's 2022 tribal consultation list and the Department of Housing and Urban Development Tribal Directory Assessment Tool (TDAT) for Bernalillo County. This list is identical to the list submitted to you on November 7, 2022, and includes the recommendations made by your office on the call with VA contractors on November 3, 2022. VA provided the tribes with the same information that was provided to NPS in the November 21, 2022 communication; however, tribes were also provided the 2018 Archaeology Report (Attachment C) in the initial mailing. Of the 37 parties invited to consult, VA has

received five responses as of the writing of this letter (Attachment B). These responses were submitted by:

1. your office;

- 2. the NM SHPO, who requested the visual APE be expanded to include the Petroglyph National Monument, and who concurred with a finding of no adverse effect to historic properties;
- 3. the Pueblo of Tesuque, who accepted VA's invitation to consult, but did not provide comments;
- 4. Historic Albuquerque Inc., who did not request to participate, but offered design assistance in the future, if needed: and
- 5. the Director of the Parks & Recreation Department, David J. Simon, of the City of Albuquerque's Open Space Division, who provided updated contact information, but did not provide comments.

The 2017 consultation resulted in two Section 106 responses (Attachment D): the NM SHPO requested an updated archaeological survey and confirmation of tribal consultation, and the Pueblo of Sandia replied that due to the "close proximity to pueblo lands, cultural sites, and historical properties which may be affected in this endeavor it will be in our best interest to participate in the consulting process." The Pueblo of Sandia did not submit comments when VA recontacted them in 2022.

VA acknowledges NPS' recommendation to design the cemetery in a manner that will reduce or eliminate visual impacts to Petroglyph National Monument. The design of the cemetery is anticipated to be low-lying, with no elements over two stories, and VA agrees with the NM SHPO, who stated in their concurrence letter: "In our view, the Undertaking will have no adverse effect on historic properties because the proposed cemetery will be visible but will comprise a low-lying, landscaped area with few buildings."

VA also acknowledges NPS' request for a "water-wise" design incorporating low water and native vegetation. This request has been shared with NCA leadership and is currently under active consideration. VA has several cemeteries where this design approach has been successfully used, including at Fort Bliss National Cemetery and the Bakersfield National Cemetery. The websites linked demonstrate the type of water-wise design VA has used in similar climates.

VA will share plans for the cemetery at the approximately 30%, 60%, and 90% design stages with your

office and any other consulting parties that request to see them, for review and comment. VA will take any timely comments received into consideration in finalizing the plans. While VA appreciates the offer to coordinate access to the monument to generate visual simulations of views of the cemetery from the monument, VA does not feel that is necessary due to the low-lying design and the distance between the monument and the cemetery. If design parameters change, and buildings over two stories are proposed, VA will revisit this request.



The U.S. Fish and Wildlife Service (Service) has responsibility for certain species of New Mexico wildlife under the Endangered Species Act (ESA) of 1973 as amended (16 USC 1531 et seq.), the Migratory Bird Treaty Act as amended (16 USC 701-715), and the Bald and Golden Eagle Protection Act as amended (16 USC 668-668(c)). We are providing the following guidance to assist you in determining which federally imperiled species may or may not occur within your project area, and to recommend some conservation measures that can be included in your project design.

The enclosed species list identifies threatened, endangered, proposed and candidate species, as well as proposed and final designated critical habitat, that may occur within the boundary of your proposed project and/or may be affected by your proposed project. The species list fulfills the requirements of the U.S. Fish and Wildlife Service (Service) under section 7(c) of the ESA of 1973, as amended (16 U.S.C. 1531 *et seq.*).

New information based on updated surveys, changes in the abundance and distribution of species, changed habitat conditions, or other factors could change this list. Please feel free to contact us if you need more current information or assistance regarding the potential impacts to federally proposed, listed, and candidate species and federally designated and proposed critical habitat. Please note that under 50 CFR 402.12(e) of the regulations implementing section 7 of the ESA, the accuracy of this species list should be verified after 90 days. The Service recommends that verification be completed by visiting the ECOS-IPaC website at regular intervals during project planning and implementation for updates to species lists and information. An updated list may be requested through the ECOS-IPaC system by completing the same process used to receive the enclosed list.

The purpose of the ESA is to provide a means whereby threatened and endangered species and

the ecosystems upon which they depend may be conserved. Under sections 7(a)(1) and 7(a)(2) of the ESA and its implementing regulations (50 CFR 402 *et seq.*), Federal agencies are required to utilize their authorities to carry out programs for the conservation of threatened and endangered species and to determine whether projects may affect threatened and endangered species and/or designated critical habitat.

A Biological Assessment is required for construction projects (or other undertakings having similar physical impacts) that are major Federal actions significantly affecting the quality of the human environment as defined in the National Environmental Policy Act (NEPA; 42 USC 4332(2) (c)). For projects other than major construction activities, the Service suggests that a biological evaluation similar to a Biological Assessment be prepared to determine whether the project may affect listed or proposed species and/or designated or proposed critical habitat. Recommended contents of a Biological Assessment are described at 50 CFR 402.12.

If a Federal agency determines, based on the Biological Assessment or biological evaluation, that listed species and/or designated critical habitat may be affected by the proposed project, the agency is required to consult with the Service pursuant to 50 CFR 402. In addition, the Service recommends that candidate species, proposed species and proposed critical habitat be addressed within the consultation. Under Executive Orders 11988 and 11990, Federal agencies are required to minimize the destruction, loss, or degradation of wetlands and floodplains, and preserve and enhance their natural and beneficial values. These habitats should be conserved through avoidance, or mitigated to ensure that there would be no net loss of wetlands function and value.

We encourage you to use the National Wetland Inventory (NWI) maps in conjunction with ground-truthing to identify wetlands occurring in your project area. The Service's NWI program website, <u>www.fws.gov/wetlands/Data/Mapper.html</u>, integrates digital map data with other resource information. We also recommend you contact the U.S. Army Corps of Engineers for permitting requirements under section 404 of the Clean Water Act if your proposed action could impact floodplains or wetlands.

#### **MIGRATORY BIRDS**

In addition to responsibilities to protect threatened and endangered species under the ESA, there are additional responsibilities under the Migratory Bird Treaty Act (MBTA) and the Bald and Golden Eagle Protection Act (BGEPA) to protect native birds from project-related impacts. Any activity, intentional or unintentional, resulting in take of migratory birds, including eagles, is prohibited unless otherwise permitted by the Service (50 CFR 10.12 and 16 USC 668(a)). The MBTA has no provision for allowing take of migratory birds that may be unintentionally killed or injured by otherwise lawful activities. It is the responsibility of the project proponent to comply with these Acts by identifying potential impacts to migratory birds and eagles within applicable NEPA documents (when there is a Federal nexus) or a Bird/Eagle Conservation Plan (when there is no Federal nexus). Proponents should implement conservation measures to avoid or minimize the production of project-related stressors or minimize the exposure of birds and their resources to the project-related stressors. Executive Order 13186 thereby provides additional protection for both migratory birds and migratory bird habitat. How is the probability of presence score calculated? The calculation is done in three steps:

- 1. The probability of presence for each week is calculated as the number of survey events in the week where the species was detected divided by the total number of survey events for that week. For example, if in week 12 there were 20 survey events and the Spotted Towhee was found in 5 of them, the probability of presence of the Spotted Towhee in week 12 is 0.25.
- 2. To properly present the pattern of presence across the year, the relative probability of presence is calculated. This is the probability of presence divided by the maximum probability of presence across all weeks. For example, imagine the probability of presence in week 20 for the Spotted Towhee is 0.05, and that the probability of presence at week 12 (0.25) is the maximum of any week of the year. The relative probability of presence on week 12 is 0.25/0.25 = 1; at week 20 it is 0.05/0.25 = 0.2.
- 3. The relative probability of presence calculated in the previous step undergoes a statistical conversion so that all possible values fall between 0 and 10, inclusive. This is the probability of presence score.

#### Breeding Season (=)

Yellow bars denote a very liberal estimate of the time-frame inside which the bird breeds across its entire range. If there are no yellow bars shown for a bird, it does not breed in your project area.

#### Survey Effort ()



# Tell me more about conservation measures I can implement to avoid or minimize impacts to migratory birds.

Nationwide Conservation Measures describes measures that can help avoid and minimize impacts to all birds at any location year round. Implementation of these measures is particularly important when birds are most likely to occur in the project area. When birds may be breeding in the area, identifying the locations of any active nests and avoiding their destruction is a very helpful impact minimization measure. # Figure 1: Site Location Map




Figure 2: Topographic Site Location Map



# Figure 1: Site Location Map




Figure 2: Topographic Site Location Map

#### Hi Carrie,

The water lines serving Double Eagle Airport are restricted to a limited number of customers by the EPC Official Notification of Decision for Project 1002177/02EPC-01357, dated October 17, 2002. That document states: "The purposes of these pipelines will be to serve the airport, the Soils Amendment Facility and the Shooting Range Park. There are no other facilities or development to be served by this infrastructure." The site described in the draft EA would need to be served by the infrastructure planned for the Upper Petroglyphs area. The Water Authority does not know the developer's timeline for expansion of other infrastructure to this area. The Upper Petroglyphs planning documents did not include plans for extension of reuse water lines to this area. Reuse service on the westside of Albuquerque will be dependent upon construction of the planned Westside/Bosque Reuse Facility near Montano Blvd. and Coors Blvd., followed by extension of reuse pipelines from that facility to the surrounding areas.

The Albuquerque Bernalillo County Water Utility Authority (Water Authority) has an approved development agreement that governs provision of water and sewer service to development in the Upper Petroglyphs area. At this time, water and sewer service are not available in the area described for this project. Extension of service would require construction of master plan infrastructure in accordance with the approved planning documents for the Upper Petroglyphs area. Extension of service would include installation of approximately 3 miles of 24-inch diameter water transmission lines and approximately 3 miles of 12-inch sewage collector lines. Construction of this infrastructure must be paid for by the developer of the property in accordance with the Water Authority's policies stating that development will occur at no-net-expense to current customers. In addition, to support conservation of resources this type of facility should be constructed in an area where reuse water (treated wastewater effluent) is available for service to irrigate the green spaces. Water Authority policies support using reuse water for turf irrigation. The Water Authority has reuse water service available or planned to be available throughout much of the service area.
