

The Department of Veterans Affairs (VA) is proposing to construct and operate a VA Outpatient Clinic (OPC) and VA National Cemetery on a portion of the former Naval Air Station (NAS) Alameda in the City of Alameda, California. Under Section 106 of the National Historic Preservation Act, as amended, (Section 106), VA has initiated consultation with the California State Historic Preservation Officer (SHPO). We are writing to inform you of the status of the Section 106 process for this project, and of your opportunity to participate in the process.

As part of the Section 106 process, VA will provide consulting parties an opportunity to review the Finding of Effect (FOE) report to assess the effects of VA's proposed undertaking prior to submittal of the FOE to SHPO, to ensure that the FOE incorporates consulting party input, as appropriate.

Project Overview

The former NAS Alameda is located at the western end of the City of Alameda, along the eastern side of San Francisco Bay (see Exhibit 1). The project site comprises the inactive airfield area of the former NAS Alameda, which is developed with runways and taxiways, former aircraft maintenance facilities, associated airfield structures and equipment, and several small bunkers formerly used for ammunition storage. This area is currently owned by the Department of the Navy (Navy), which proposes to transfer approximately 623 acres (Transfer Parcel) to VA as part of the disposal of excess property.

The proposed undertaking would involve development of VA facilities on approximately 112 acres (the VA Development Area) of the approximate 623-acre Transfer Parcel, as follows:

- a. Construction and operation of a 158,000-square foot, two-story VHA OPC (on 20 acres), which would also house behavioral health facilities, a VBA Outreach Office, and NCA Public Information Center and offices;
- b. Construction and operation of a NCA cemetery (on 80 acres), including administrative and maintenance facilities located within the OPC building. The columbaria would contain niches for housing cinerary urns containing cremated remains;
- c. Construction and operation of a 2,500-square foot, one-story Conservation Management Office (on 2.4 acres) to support management of the Federally-listed endangered species - California Least Tern (CLT);

- d. Use of existing bunkers for storage of emergency supplies and use of the undeveloped area within the Transfer Parcel for emergency training exercises during CLT non-breeding season and as a staging area during emergencies and natural disasters; and
- e. Installation/construction of both on- and off-site utilities and roadways (including upgrades) necessary to serve the above-listed facilities (approximately 10 acres on site and 6 acres off site); and
- f. Management of the approximate 511-acre undeveloped area (which includes the 9.7-acre CLT colony) for the long-term persistence and sustainability of the CLT

The Area of Potential Effect (APE) includes the areas of proposed VA development and encompasses the construction footprint and all construction areas where potential project-related effects may occur (see Exhibit 2). This APE includes the approximate 112-acre VA Development Area and the proposed approximately 6-acre access road/ utility corridor that runs east from the eastern edge of the Transfer Parcel to tie into the main sewer and water utilities. The access road/utility corridor includes approximately 1,425 feet of West Redline Avenue directly east of the VA Transfer Parcel to the entry road from the Alameda Point North Gate, and a 3,292-foot segment of Main Street that extends from the Alameda Point North Gate east to the where utilities would tie into the main sewer and water utility. At the request of the SHPO, the APE also includes the adjacent NAS Alameda Historic District to ensure analysis of the potential for indirect, visual effects on the district. No VA development is proposed within the district boundaries.

You will be notified when the draft FOE is ready for review, which is currently estimated for October 2012. Should you have any questions about this undertaking, you may contact Doug Roaldson at (707) 235-4602.



Subject: Section 106 Initiation for the Alameda Point Veterans Affairs Outpatient Clinic and National Cemetery

Dear Mr. Donaldson:

The Department of Veterans Affairs (VA) is proposing to construct and operate a VA Outpatient Clinic (OPC) and VA National Cemetery on a portion of the former Naval Air Station (NAS) Alameda in the City of Alameda, California. Per the requirements of the National Historic Preservation Act (NHPA), VA is contacting you to initiate consultation under Section 106 of the NHPA for the proposed undertaking. At this time, VA is requesting your concurrence with the delineation of the Area of Potential Effect (APE) and the plan for consultation/public involvement.

Definition of Undertaking

The former NAS Alameda is located at the western end of the City of Alameda, along the eastern side of San Francisco Bay (see Figure 1). The project site comprises the inactive airfield area of the former NAS Alameda, which is developed with runways and taxiways, former aircraft maintenance facilities, associated airfield structures and equipment, and several small bunkers formerly used for ammunition storage. This area is currently owned by the Department of the Navy (Navy), which proposes to transfer approximately 623 acres (Transfer Parcel) to VA as part of the disposal of excess property.

Consistent with 36 Code of Federal Regulations 800.3(a)(1), VA and Navy have determined that the Federal-to-Federal transfer of property from Navy to VA—as a transfer of property from one Federal agency to another with the property remaining in Federal ownership—is not an undertaking that has the potential to affect historic

properties. Therefore, this consultation focuses on VA's subsequent undertaking, which includes the construction and operation of the OPC and National Cemetery.

The proposed undertaking is designed to serve the multiple needs of San Francisco Bay Area Veterans by constructing and operating VA facilities that are co-located on one site. The primary elements of the services to be provided to Veterans shall include:

- Veterans Health Administration (VHA) OPC – including an Ambulatory Care Clinic, VA/Department of Defense (DoD) Ambulatory Surgery Center, and the potential for a jointly-staffed VA/U.S. Coast Guard Women's Health Clinic.
- National Cemetery Administration (NCA) – VA Cemetery to serve the long-term interment needs of San Francisco Bay Area Veterans through construction of an above-ground columbarium cemetery for cremated remains.
- Veterans Benefits Administration (VBA) – A VBA Outreach Office co-located with NCA and VHA services in the VA OPC building to provide benefit services to Veterans.

The proposed undertaking would involve development of VA facilities on approximately 112 acres (the VA Development Area) of the approximately 623-acre Transfer Parcel, as follows (Figure 2):

- Construction and operation of a 158,000-square foot, two-story VHA OPC (on 20 acres), which would also house Behavioral Health facilities, a VBA Outreach Office, and NCA Public Information Center and offices;
- Construction and operation of an NCA cemetery (on 80 acres), including administrative and maintenance facilities located within the OPC building. The columbaria would contain niches for housing cinerary urns containing cremated remains;
- Construction and operation of a 2,500-square foot, one-story (maximum height of 25 feet) Conservation Management Office (on 2.4 acres) to support management of the Federally-listed endangered species - California Least Tern (CLT);
- Use of existing bunkers for storage of emergency supplies and use of the undeveloped area within the Transfer Parcel for emergency training exercises during the CLT non-breeding season and as a staging area during emergencies and natural disasters;
- Installation/construction of both on- and off-site utilities and roadways (including upgrades) necessary to serve the above-listed facilities; and

- Management of the approximately 511-acre undeveloped area (which includes the 9.7-acre CLT colony) for the long-term persistence and sustainability of CLT.

Area of Potential Effect

The APE includes the areas of proposed VA development and encompasses the construction footprint and all areas where potential project-related effects may occur (see Figure 2). The APE includes the approximately 112-acre VA Development Area and the proposed approximately 6-acre access road/utility corridor that would run east from the eastern edge of the Transfer Parcel to tie into the main sewer and water utilities. The access road/utility corridor would include approximately 1,425 feet of West Redline Avenue, directly east of the VA Transfer Parcel to the entry road from the Alameda Point North Gate, and a 3,292-foot segment of Main Street, that extends from the Alameda Point North Gate east to where the utilities would tie into the main sewer and water system.

Identification of Historic Properties

The former NAS Alameda was constructed in the 1930s, prior to World War II, and played an active role in the war. NAS Alameda was decommissioned in 1997. A portion of the naval air station comprises the NAS Alameda Historic District, which is eligible for listing in the National Register of Historic Places (NRHP) with a period of significance from 1938 to 1945. The NAS Alameda Historic District is located directly east of the proposed undertaking.

A records search for the undertaking was initiated through the Northwest Information Center on March 21, 2012.

Previous Studies and Consultations

In 1999, the Navy entered into a Section 106 Memorandum of Agreement (MOA) titled *Memorandum of Agreement Among the United States Navy, the Advisory Council on Historic Preservation and the California State Historic Preservation Regarding the Layaway, Caretaker Maintenance, Leasing, and Disposal of Historic Properties on the Former Naval Air Station, Alameda, California* (1999 MOA). The MOA identified the NAS Alameda Historic District, the south jetty of the Oakland Inner Harbor, and the Jetties and Federal Channel Historic District (Alameda Training Wall) as historic properties. The 1999 MOA did not identify any archaeological sites eligible for the NRHP.

Since 1999, the Navy has completed two base-wide evaluations to complete the identification of historic properties at the former NAS Alameda. These evaluations

resulted in the preparation of the *Combined Specific Buildings Survey and Evaluation Report/Cold War Era Historic Resources Survey and Evaluation Report for Naval Air Station Alameda* (September 2011) (Combined Evaluation Report) and the *Cultural Landscape Report (CLR) for Naval Air Station Alameda* (April 2012). The California State Historic Preservation Officer (SHPO) concurred with the findings of the Combined Evaluation Report on January 7, 2011, and May 31, 2011 (USN090603A), and with the findings of the CLR on March 19, 2012 (USN120221A).

The Combined Evaluation Report identified additional World War II-era contributing elements of the NAS Alameda Historic District and concluded that the historic district includes 99 contributing resources. The NAS Alameda Historic District is located east of the APE for the current undertaking, and the Combined Evaluation Report did not identify any historic properties within the APE.

The CLR identified a historic designed landscape as an additional contributing element of the NAS Alameda Historic District. The CLR concluded that no NRHP-eligible cultural landscapes or landscape features occur outside the historic district boundary. Therefore, the CLR did not identify any historic properties within the APE for the current undertaking.

Plan for Public Involvement/Coordination with National Environmental Policy Act Review

For the proposed undertaking, VA plans to build upon the Navy's previous consultations and integrate efforts to provide the public with an opportunity to comment under Section 106 with other public involvement processes such as those planned for National Environmental Policy Act (NEPA) review. VA will conduct the following outreach to potential consulting parties in the Section 106 process:

- VA will establish a list of consulting parties, taking into account the Navy's list of consulting parties from the historic property identification effort as well as VA's procedures for identifying consulting parties;
- VA will notify consulting parties in writing that Section 106 consultation has been initiated with SHPO and that they will have an opportunity to comment on the effects of the undertaking through a review of the Finding of Effect (FOE) report and at the NEPA public meeting held during the public review period for the NEPA Environmental Analysis, which is being jointly prepared by VA and the Navy;
- VA will provide consulting parties an opportunity to review the assessment of the effects of VA's proposed undertaking prior to submittal of the FOE to SHPO, to ensure that the FOE incorporates consulting party input, as appropriate; and

- VA will inform the public about the Section 106 process and findings during the NEPA public meeting discussed above, and will consider comments received.

Summary

VA anticipates that the identification phase of Section 106 review for the proposed undertaking will be based on the existing documentation prepared for former NAS Alameda. Information from these studies will be summarized and used to prepare the effects analysis for the undertaking. VA will consult with SHPO on its findings through a request for concurrence on the FOE report.

VA is requesting consultation on the proposed undertaking—the construction and operation of the VA OPC and National Cemetery—to fulfill Section 106 requirements of the NHPA. VA is also requesting SHPO comments and concurrence with the delineation of the APE and the plan for consultation/public involvement.


- Figure 1 (Project Location and Vicinity)

Dear Doctor O'Neill:

Thank you for initiating consultation on behalf of the Department of Veteran's Affairs (VA) regarding their efforts to comply with Section 106 of the National Historic Preservation Act of 1966 (16 U.S.C. 470f), as amended, and its implementing regulation found at 36 CFR Part 800.

The VA has identified the undertaking as the construction and development of several facilities, such as a National Cemetery and Outpatient Clinic, at the Former Naval Air Station Alameda. Ownership of former NAS Alameda, including the NAS Alameda Historic District, is currently being transferred from the U.S. Navy to the VA. Extensive construction and development of the former air station is being proposed by the VA, however at this time they are only requesting concurrence with their Area of Potential Effect (APE) determination, and consultation and public outreach methodology.

After reviewing the submitted information, I have the following comments:

- 1) As illustrated by maps submitted by the VA, proposed construction will occur adjacent to the NAS Alameda Historic District. Therefore, all designs for new construction and features visible from the district must be developed and consulted upon with that in mind. I suggest the VA amend the APE for all construction to include the NAS Alameda Historic District. If you agree with this modification I concur that the APE has been properly determined and documented pursuant to 36 CFR Parts 800.4 (a)(1) and 800.16(d). Please provide an updated map and narrative description of the modified APE at your earliest opportunity. If the VA does not agree with this proposal, please notify my office in writing.
- 2) I agree with the VA's proposed approach to public consultation for this undertaking as detailed on page four of their 13 August 2012 letter to my office. Please be reminded that such consultation must include the notification and

solicitation of comments from tribes identified through the Native American Heritage Commission. All comments received during this period must be included in the VA's Section 106 submittals to my office.

- 3) I agree with the VA's approach to identifying historic properties within the APE pursuant to 36 CFR Part 800.4. This proposed course of action will borrow from the findings of previous surveys and context reports pertaining to former NAS Alameda in addition to public outreach. Any remaining issues or questions arising from this procedure will be addressed through the Section 106 consultation process before the final determination of effect is identified.
- 4) It is my understanding that the VA will continue to consult with my office for *all* proposed actions at former NAS Alameda.
- 5) This letter does not address any construction activities and pertains solely to the VA's request for concurrence with identification efforts, public outreach and APE delineation.
